

# Raynham Parish Council

# Meeting Minutes

Tuesday 22 July 2025

Parish Councillors present: David Sidell (Chariman), Richard Brooke (Vice Chair), Tim Mudd, Barry Sergeant, Andrew Buck, Tom Raynham and Tom FitzPatrick (County Councillor). Also in attendance: Jodie Bond (Parish Clerk). There were no members of the public present.

#### 1. Welcome and to receive apologies for absence

The Chairman welcomed all those present. Apologies received from Nigel Housden (District Councillor). Apologies accepted.

Also the white lining has been carried out on the A1065 but following a drive round with the Highways Inspector Cllr FitzPatrick has asked for more SLOWs to be painted on the road and the Highways Inspector will be measuring up for the new Wig Wags, which will be solar powered, and agreeing the final positions of the poles.

Cllr Sidell asked about the progress with the Western Link. Cllr FitzPatrick replied that it is still on hold due to Natural England not granting a licence, so the DfT are looking at another route.
